2018 Budget Available for Review

The board has worked diligently over the last few months to work out a budget for 2018 that is balanced and reflects the expected income from General assessments. A copy of that budget is included in this mailing for all members to review. This budget will be approved by the board at the December board

meeting, and members who have questions or concerns are encouraged to submit those thoughts to the office ahead of the meeting or attend the meeting in person.

As you review the budget you may notice a few things. First, the Lake fund appears to be operating at a deficit. The Lake Fund is used for major programs and therefore cash is carried over

from year to year to cover projects. Additionally, you will notice there is no Road Fund budget this year. Due to the instatement of the SSA, there will be no income to the Road Fund unless the membership approves some at the annual meeting in March. As a result, the Road Construction projects that are planned will be funded through the SSA.

SSA and Road Improvements

Over the summer, several road construction, culvert repair, and ditch improvement projects were Westinster Drive. completed in advance of the finalization of the SSA. All this work was funded by this year's Road Fund Assessment. The work allowed the association to protect some of the roads that were in better condition from further deterioration over the winter, before the major construction begins next year. For the remainder of 2017, only patching will be done.

As part of the preparation for the SSA billing, the board and office have compiled a list of all owners and the Property Tax IDs associated with the property they own. The SSA has been structured to be charged like the Road fund was, once per owner for the same amount to each owner.

The Property owner list will be updated each year and be made available to members to review once it is complete. The first list will be available on the website and at the office after December 1. The Board is asking all members to please verify their information on the list is correct so that all property owners are billed for the SSA correctly on their tax bills that will be due in 2018.

The Road Committee continually posts their activities as well as expenditures on the Heritage Lake website. Please review if you have auestions.

Winter Road Restrictions

Road weight limit: The winter weight limits officially go into effect on January 1, 2018. Please obey these weight limits to help save our roads. If you notice a violation, please report it to the HLA board or the office.

The limits are as follows: No vehicle, trailer, or cargo may be driven upon any Subdivision roads exceeding a weight limit of 6 tons (12,000 lbs.) from the period of January 1 through April 15 unless given proper permission by the Subdivision Board.
