Committee Reports

Member Chaired

Conservation

- Spillway and Dam project HLA attorney Mooty is working on this project with the State of Illinois to define their requirements and resolve the issues.
- Complaint from member who lives at the base of Raleigh Drive. There is a difficult drainage problem in his yard due to the flow of water from the road. This member is a heavy equipment operator and has offered to trench the area. Will also look to a vender to dig a trench to channel the water directly into the sediment basin. Need to manage this sediment basin. This will also allow HLA trucks easier access to the basin. Bids are being sought. Will go with committee recommendation.
- Sandy Beach sediment basin is too wet to clean out at this time. Discussion to install a rock pad that would create a platform allowing easy access for cleaning.
- The current rate to clean-out and haul away the material from a sediment basin is \$12,000.
- Working on fish stocking for November.
- Member Stickrod is ready to proceed with lake spraying.

Environmental Control

- 1 Tree Permit 22 Brandy Lane
- 1 Shed Permit 42 Yorkshire Drive
- Talked to homeowner at 25 Greenbriar Drive with regard to an undersized culvert that needs to be replaced.

Road Committee

- Ditch work to begin on Kent Avenue, King Richard Drive, Yorkshire Drive and Carlton Drive.
- JULIE out to mark utilities 8 business days late. Contractor Jeff Miller is informed.
- JULIE is behind schedule and supposed to send someone to work full- time. Has not caused major delays yet.
- Some member dissatisfaction with ditches and culverts going in. Road Chair Reed has responded to most all. Facts have been stated.
- SSA a few member questions concerning tax bills. These have been resolved by meeting with members.
- 2 Thornton Drive had concerns with culvert and ditch plans. Plan has been changed accordingly.
 No culvert, but a ditch will be installed.
- Question concerning culvert replacement on Roxbury Road. Road Chair Reed explained the work to be done.
- Member at 13 Kent had concern that water will be directed toward his lot with a ditch; work will be done according to engineer recommendations.
- On King Richard, a section of culvert was buried underground and filled in. The engineer
 recommends establishing a ditch and installing a new culvert. The property owner had wanted to
 do the work himself. Director Cassatt has discussed this with him. There is a possibility that the
 ditch work could be added at the end of the contract. The culvert must be approved by E.C.C..
- Chair Reed will post on the website what materials are acceptable for culvert use.
- The road bid process has ended and the county committee was to open the bids today. No feedback yet as to results of the bidding.
- SSA commission will meet this Thursday, May 24, 2018. The recommended bid will be reviewed and approved. The final approval will be decided by the County Board at their next meeting.
- Speed bumps will be installed after September 1st.
- The last contract this year will be for crossroad culvert lining. The work will be done later this fall.
- Numerous vehicles parked on Beechwood Road are preventing necessary road work from being done. A second letter will be sent to the property owner requesting removal of the vehicles and Officer Davis will be asked to visit the property, if necessary.
