Treasurer's Report

All data presented is as of July 31, 2019.

The Total Cash Balance is \$1,482,598.58 and is made up of the following fund balances:

Emergency Fund ...\$127,025.90 General Funds\$978,325.36 Lake Funds\$248,795.92 Road Funds\$128,424.40

The above funds include checking and CDAR accounts.

The outstanding receivables total is \$153,336.94, a decrease of \$5,290.05. For additional breakdown, please refer to the attached Balance Sheet.

The Year-to-Date Net Income is \$106,996.63 with Revenues of \$287,444.22 and Expenses of \$180,447.59. Please see the attach Profit and Loss Statement for further detail.

As for actual Cash details, for the month of June the cash deposits were \$8,720.78 and the cash expenditures were \$41,680.20. Expenditures include transfer of \$12,957.00 from the General Fund to the Emergency Fund. Additional report details are posted on the Heritage Lake website.

There were no unusual expenses in July. ++

Lake Fund statements will be mailed this week and are due October 1, 2019.

Letters were sent to 30 members with outstanding assessments that are greater than \$500 and more than 120 days in arrears advising them that their account would be sent to collections in 14 days. Two members paid the full amount and three initiated a payment plan. We met with the collections attorney to discuss our account and additional efforts to contact and collect old as well as new claims.

The Finance Committee did not meet in July.
