WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

I, on behalf of myself and any minor child/children for whom I can contract, hereby acknowledge and agree to the following in consideration for receiving permission of the Heritage Lake Association (hereinafter the "Association"), to participate in Association activities, and use its facilities and equipment:

1. I understand that the activities that I or my minor children may participate in on Association property involve the risk of harm and have inherent dangers; specifically including activities involving the Association's swimming pool, lake, and recreational facilities (Activities).

2. I understand the dangers of the novel coronavirus ("COVID-19") and am familiar with the Centers for Disease Control and Prevention ("CDC") and State of Illinois guidelines for public activities regarding COVID-19. I acknowledge and understand that the circumstances regarding COVID-19 are changing from day to day and that, accordingly, the CDC and state and local guidelines are regularly modified and updated and I accept full responsibility for familiarizing myself with the most recent updates.

3. I agree that and my minor children or guests will abide by and follow all Association rules and requirements for COVID-19 safety and prevention including social distancing, masks, limits on participants, and I will quarantine if exposed to persons with COVID-19 or if I have or believe I have COVID-19.

4. I also consent to the Association cooperating with and reporting COVID-19 incidents and information to emergency and medical providers, public health personnel, contact tracers, and the Association membership.

5. I understand that the Association may close or limit access to Association property based on its assessment of health risks, insurance coverage requirements, and government orders or regulations.

6. I acknowledge and fully assume the risk of injury, illness, or death related to my participation in activities or presence on Association property including COVID-19 and hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE (on behalf of myself and any minor children from whom I have the capacity contract) the Heritage Lake Association, its members, their owners, officers, directors, agents, employees, volunteers, service providers and contractors (the "RELEASEES") from any liability which might occur as a result my being on the premises and participating in the Activities including illness or death due to COVID-19.

7. I shall indemnify, defend and hold harmless the RELEASEES from and against all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees, costs and disbursements, and whether or not an action is brought, on appeal or otherwise), arising from or out of, or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury caused from my being on Association property or participating in the Activities.

8. It is my express intent that this Waiver and Hold Harmless Agreement shall bind any heirs, assigns, and representatives, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the above-named RELEASEES.

9. The laws of the State of Illinois shall govern this Agreement.

BY SIGNING THIS AGREEMENT, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Wavier of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my free act; I am at least eighteen (18) years of age and fully competent; and I execute this Agreement for full, adequate and complete consideration fully intending to be bound by same.
